## 1) Artist Terms and Conditions

- a) All artists 2D must be financial members of WASA.
- b) 3D Artworks Exceptional fee for non-members; choose Package One or Package Two.
- c) It is a condition of entry that artists also contribute to volunteering for the event. We welcome country artists to volunteer, but it is not compulsory.

#### 2) All Artworks 2D & 3D

- a) All artworks submitted must be for sale.
- b) Artists may exhibit up to three artworks.
- c) An image(JPEG) of the artwork registered is required to identify the work and for WASA exhibition quality control.
- d) New or unexhibited artwork is encouraged.
- e) All artworks must be dry and stable.
- f) A pair or triptych may be entered and counted as one artwork.
  - g) The decision to display artwork lies with the exhibition coordinators.



#### 3.1) 2D Artwork

- a) 2D artwork 1 x metre with a 10 cm allowance due to the canvas size available through retailers.
- b) All hanging artworks must have a suitable hanging wire or cord, suitably fixed, as the cord hangs them, not the D-ring.
- c) Hanging artworks must have taped up and cover all metal hanging devices (such as screws, D-rings, etc.) to prevent damage to other artworks.

#### 3.2) 3D Artwork

- a) 3D artwork should be no more than 1 metre with a 10cm allowance and be of a manageable weight.
- b) Artists wishing to submit a sculptural piece of over-size are advised to contact Ernst Schneider well in advance on Mobile: 0490 291 379
- c) All 3D artworks must be professionally presented for sale and exhibition.
- d) 3D artwork will be placed on a plinth. For special display arrangements, please get in touch with the 3D Coordinator, Ernst Schneider Mobile: 0490 291 379 Email: eschneider1291@gmail.com
- e) Artists of 3D works must be prepared to assist in placing heavy works.

## 10) Exhibitor Content

- a) On the sale of any pieces of artwork, a "Certificate of Authenticity" will be issued.
- b) Artworks must be an original work of the artist.
- c) Copies of another artist's work are ineligible.
- d) Copies from another source must not infringe on copyright.
- e) Artworks can be from a photograph if the copyright is with the artist.
- f) Portrait artwork must have the permission of the sitter.
- g) Artwork completed during workshops or with assistance is not eligible.
- h) Mass-produced artworks will not be accepted.
- i) Artworks must not have been exhibited in the past 12 months in any other West Australian exhibition.
- j) Artworks must not have won any previous awards or prizes.

## 11) Categories for 2024

- a) En Plein Air
- b) Oil & Acrylic painting.
- c) Mixed Media, including Printmaking, Illustration, Drawing and Oil pastels.
- d) Watercolour painting.
- e) Pastel painting.
- f) 3D Art, including sculpture, ceramics, glass, and textiles.

## 12) Category Definitions

- a) En Plein Air: painting must have been completed wholly in situ outside with no studio work as part of the process.
   Work must be done unassisted.
- b) Oil & Acrylic
- c) **Oil**: Two-dimensional artworks mostly completed in oils, including oil bars.

Acrylic: Two-dimensional artworks mostly completed in acrylics, including acrylic inks.

d) Mixed Media: Two-dimensional artworks comprised various media, including oil, acrylic, textile, watercolour, pastel, etc. Artwork in which more than one medium or material has been employed, including a combination of painting or drawing techniques or materials, such as collages, assemblages, found objects, printmaking, illustration and drawing.

A variety of media will be accepted if it is in the style of the drawing process. Media such as graphite, charcoal, oil pastels, and dry pastels will be allowed.

- e) **Watercolour Painting**: Traditional forms of watercolour include gouache, aquarelle, and casein.
- f) Pastel painting: Traditional dry pastel or pan pastel.
- g) 3D Art encompasses all artistic forms of three-dimensional artworks, including sculpture, ceramics, glass, textiles, woodturning, and jewellery.

All entries must be of exhibition standard and will be juried.

## Please Note:

Objects whose primary purpose and dominant aspects are function, design and/or craftsmanship do not fulfil the **artistic** criteria for this exhibition.

Therefore, general woodturning, general pottery, general jewellery, and fine furniture will not be displayed since these would be considered craft or fine furniture.

Photography or digital artwork are excluded in all categories.
