## TERMS AND CONDITIONS

- I am a current member of WASA, with any membership fees being fully paid
- Eols are limited to one piece of original art per artist, inspired by the theme “**Access to Justice**”
- I understand that this is an Eoi and final decisions regarding exhibition will be made by Law Access
- The work must be original and completed by the artist in the past 2 years
- The work meets size and weight dimensions
  - 2D artwork – no side larger than 120cm
  - 3D artwork – not more than 120cm x 120cm in dimension
  - All pieces to weigh less than 10kgs
  - All submissions require the self-supply of an easel. Desk easels are encouraged where possible
  - 3D work will be exhibited on tables
- All pieces submitted must be available for sale
- There is no entry fee and a commission of 20% is payable on all sales (10% WASA, 10% Law Access)
- All art must be wrapped for transport - transport, handling, exhibition is at the artist’s own risk**
- It is the artist's responsibility to drop off / pick up artwork at the allocated times**
  - Monday 30th Sep - EOIs close
  - Friday 4 Oct – artists notified whether accepted for exhibition
  - Sunday 13 Oct – artwork (and easel) drop off at Law Access<sup>1</sup> from 4-5pm
  - Monday 14 Oct – Exhibition at Minter Ellison<sup>2</sup> from 530pm – 9 pm (exhibiting artists may attend)
    - Note that artwork may also be dropped off between 11.30am and 5pm
    - Unsold artwork can be collected by artists in attendance at conclusion of event
  - Tuesday 15 Oct – Remaining artwork and easel pick up from Minter Ellison (time to be announced)
